Presbyterian Women continues to work on commitments to be an inclusive, caring community and an anti-racist organization. Dismantling structural racism is a key area of the Matthew 25 vision for the PC(USA). PW supports this vision. This PW advisory group will provide focused attention on short- and long-term strategies that impact structural racism, including education/training, culture, policy, procedure, participation, and leader recruitment. These efforts will help PW evaluate and renew structures and practices that impede participation and a sense of belonging for racially diverse women.
